Job Description: This is a unique opportunity to co-teach, part-time, with a highly qualified full-time teacher in a blended kindergarten through sixth grade program. This part-time teacher would serve as a source of instruction and support for approximately eight students in our rural public school four mornings a week. Specific responsibilities include supervising students within the classroom and other assigned areas; developing lesson plans and delivering group and individual student instruction within and beyond Common Core guidelines; collaborating with the other teacher, instructional assistant(s), administrators, adjuncts, parents, volunteers and students in addressing instructional, behavioral and classroom needs. Classroom and school technology includes Titanium model Promethean ActivBoards, full multimedia PA classroom system, theater stage fully wired with performance level equipment and lighting, laptops for all students, 2in1 Dell teacher laptop and additional accessories, as well as an outdoor classroom. This dynamic teaching position can be discussed and tailored based on additional talents that might lend to teaching in a mixed-grade rural school.

The candidate must be licensed by the Oregon Teachers Standards and Practices Commission. Reciprocal state licensure is also acceptable. Salary is based on qualifications and experience. This position does not include medical benefits but does include employer-paid PERS contributions if the candidate is PERS eligible.
